- **Opt-Out Mechanism:** If you no longer wish to receive text messages from us, you can opt out at any time. We will process your opt-out request promptly.
- **Privacy and Security:** We take appropriate measures to protect your personal information, including your phone number, and ensure that it is used in compliance with 10DLC regulations.

Sharing Your Information:

We do not share your personal information with third parties for marketing purposes. We may share your information with third parties as necessary to provide our services, comply with legal obligations, or protect our rights.

Your Rights:

You have the right to access, correct, or delete your personal information, as well as the right to restrict or object to the processing of your information.
